Approved St. Anthony School Board Transportation Guidelines For Resident Families

- Every resident has the right to district-provided transportation.
- Bus stops for resident students will be within 2 city blocks for 1st-12th graders.
- Bus stops for kindergarten students will be within 1 city block.
- Bus stop locations may change from year-to-year based on transportation needs.
- Currently, students may register to ride different busses based on parent scheduling needs (daycare, pre-school, etc.) - may change from year-to-year based on district policy.
